Dear Program Administrator:

The United States Probation/Pretrial Service Office for the Northern District of Alabama is soliciting proposals to provide urine collections/reporting, substance abuse treatment (outpatient and residential), mental health treatment, sex offender treatment, and polygraphs for male and female federal defendants and offenders who are drug dependant, alcohol dependent, and or suffering from a psychiatric disorder.

These individuals include persons on federal probation, supervised release, pretrial release, or parole who are under the supervision of the United States Probation Office.

On June 14, 2019, the required Request For Proposals (RFP) will be posted on the district's website (www.alnp.uscourts.gov) for your review. Please utilize the "Vendor" tab for information. Each RFP will contain the full text of Government regulations, and all offerors are subject to the provisions contained in the RFP. In responding to the RFP, you should answer fully each item and supply all information requested. Section "L" provides specific directions and instructions for potential vendors in completing their proposals. All proposals will be evaluated by the criteria identified in Section "M."

Proposals will be awarded on the basis of initial offers submitted, and each initial offer should contain your organization's best terms from a price and technical standpoint. There will be no additional opportunity to modify your proposal.

Please read the RFP carefully, do not rely on knowledge of previous RFPs, or knowledge of previous federal procurement documents and procedures.

The estimated monthly quantity listed in Section "B" of the RFP is the estimate of the services to be provided during the term of this agreement. It is only an estimate. Although the Government may choose to enter into a Blanket Purchase Agreement (BPA) with multiple vendors, the Government reserves the right to award to a single vendor.

The term for this BPA is 12 months, with a provision that shall allow the Government to unilaterally extend the agreement for an additional 2 years, at the Government's discretion.

A vendor must be capable of providing all services identified in Section "B" and within the geographic area identified in Section "B."

An offeror's conference will be hosted on June 25, 2019, from 10 a.m. to 12 noon, at the address listed below.
